- b) Experience in molecular characterization of dementia with Lewy bodies by neuropathological studies on brain material including immunohistochemistry-, DNA-, mRNA-, splice variant- and, miRNA-based analyses; and by the detection, functional characterization and analysis of indel-variation polymorphisms and structural variants. Experience in the design of combined data analysis strategies.
- c) Experience in molecular characterization of dementia with Lewy bodies by analyzing blood, plasma, including exosomes and platelets, and saliva samples from patients.
- d) Experience in translational research with emphasis on biomarker discovery and development through patenting; and including the establishment of multi-center collaboration networks and seeking for financing from industry.
- e) Experience in the design, development, analysis and evaluation of Nanostring-based technology.
