Pathophysiological bases of inflammatory bowel diseases. Omic, bioinformatic and experimental studies on Crohn's disease. Search for solutions for complications such as therapeutic failure or post-surgical recurrence. Identification of transcriptomic, epitranscriptomic or microbiological biomarkers. Development of new therapeutic strategies based on mesenchymal cells and adipose tissue.

The applicant must have the following qualifications:

- a) Biologist, biotechnologist or bioinformatician with a recent Ph.D.
- b) Under 30 years of age (Programa INVESTIGO).
- c) Experience in molecular analysis, cell cultures and in vitro genetic modification methods. The certificate of manipulator of experimental models "in vivo" and knowledge of microbiology are valued.
- d) Skills in handling big data and statistical analysis (knowledge of R is valued)
- e) Motivation to participate in basic-translational research studies and ability to work in a team.
